'MISSION CLEAN PUNJAB' Mohali civic body launches cleanliness drive along Balongi-Shahi Majra Road

THE MOHALI Municipal Corporation Wednesday launched a cleanliness drive along Balongi-Shahi Majra Road, the city's entry route from the Balongi side, as part of the second phase of the Punjab government's 'Mission Clean Punjab'.

DC: Farmer ID registration mandatory for cultivable landholders in Mohali

THE AGRICULTURE and Farmers Welfare Department has stressed the need for every farmer owning cultivable land to register under the Farmer Registry and obtain a Farmer ID to access government schemes and benefits.

Deputy Commissioner Komal Mittal, during a meeting with agriculture officials, directed that the registration process be expedited across the district.

Chief Agriculture Officer Dr Rakesh Kumar Sharma said the Farmer ID would be required in future to access benefits such as subsidised farm machinery, fertiliser supplies and instal-

ments under the PM-KISAN Samman Nidhi scheme.

He said there was no minimum or maximum landholding requirement for registration and that those employed or running businesses alongside farming were also eligible.

Sharma said every person whose name appears in the land records should obtain a separate Farmer ID, adding that registration of only one family member would not be sufficient.

Farmer IDs are being issued free of cost at Common Service Centres and block agriculture offices.

Farmers facing difficulties with registration can approach Agriculture Department officials for assistance, he said.

Haryana records 3,360 suicides in 2024; Health Dept stresses early mental health support

Haryana recorded 3,360 suicide deaths in 2024, according to the latest available National Crime Records Bureau data, prompting the state Health Department to call for greater awareness and timely mental health support ahead of World Suicide Prevention Day on September 10.

The department has urged people to give mental health the same importance as physical health and seek professional help for persistent stress and emotional distress.

Dr Brahmdeep Sindhu, Director, Mental Health, Haryana, said suicide could be linked to multiple factors, including prolonged stress, family or relationship difficulties, financial problems, and other mental health conditions.

"Suicide prevention is not limited to identifying mental illness. It is about supporting people through difficult circumstances, listening to them, ensuring timely access to care and creating a society where people can speak about their difficulties without fear, shame or stigma," he said.

₹250-ride quoted at ₹1,000: fares hiked as UT bans app-based cabs

FROM Rs 250 to Rs 1,000: a 300-per cent hike for a ride. Chandigarh commuters are feeling the pinch of the Uber-Rapido ban, with private cab operators demanding premium fares, leaving many scrambling for autos and CTU buses. And come Thursday, disrupted train services will add to their woes.

The UT Chandigarh Administration on Tuesday suspended the licences of Uber and Rapido for six months, cutting off two of the city's most widely used app-based cab services with immediate effect. Earlier in June, the administration had suspended the licences of Ola and inDrive. The administrative action, which the State Transport Authority (STA) says was taken after the companies failed to satisfy the prescribed regulations relating to driver insurance and training, fares, vehicle eligibility and other safety and operational norms, despite being given multiple opportunities, left passengers confused and searching for alternatives.

On Wednesday, a day after the Uber and Rapido suspension, The Indian Express did fare checks with private cabs. For a ride from Chandimandir to MCM DAV College, which would ordinarily cost around Rs 250 to Rs 300, three local cab operators

quoted between Rs 600 and Rs 1,000 for a one-way trip.

One Ronak Cabs quoted Rs 600, 22 Ji Cabs Rs 800, and Maharana Cabs Rs 1,000 for the same journey.

The steep rise in fares has particularly hit hard youngsters, mostly college students, and working professionals, who used to commute by these app-based cabs, with many now turning to autos and CTU buses.

Shivangi, a resident of Sector 35C and a teacher at SD College, says she used to take app-based cabs for her daily commute.

"With those services discontinued now, I have switched to autos. It costs me almost double to reach the college."

Yuvraj Singh, a student at Government College of Commerce, who commutes from Sector 6 to Sector 50, said, "Students like me depend heavily on app-based cabs for affordable and quick travel, especially when we have to attend classes, submit assignments or reach somewhere at short notice. With the services no longer available, commuting has become difficult and expensive, because auto

rickshaws and buses take a lot of time."

For those whose work involves frequent travel across the city, the disruption has made matters even worse.

Jaideep Singh, a young law intern at the court complex, said, "I often travel to court, offices and other places at short notice. It was convenient to get app-based cabs without worrying about parking. The suspension of services has made daily commute more cumbersome, and left fares unpredictable."

Defending the action against

the aggregators, a senior official at the State Transport Authority said, "The action has been taken as per the provisions of the law and the Chandigarh Administration Motor Vehicles Aggregators Rules. The companies had been given sufficient time and opportunities to comply with the rules and requirements before the action was taken."

App-based platforms let passengers check fares before booking; now they call private taxi operators and negotiate fares.

Also, the fare spike came at a time when train services are set to be disrupted from Thursday, adding to their woes and pushing more commuters onto the roads. Those who normally depend on trains for travel between Chandigarh and neighbouring areas will have little option but to use buses, autos and private taxis.

With the demand for road transport expected to rise, commuters fear the already steep private taxi fares could climb further. Fewer private cabs and disrupted rail connectivity could mean longer waits and higher fares for passengers.

Criminal held after gunfight with Mohali cops

A GUNFIGHT broke out between the Mohali Police and a suspected criminal near the Saneta police post on Wednesday. Both sides exchanged fire during the operation, following which police stepped up deployment in the area.

SSP Mohali Varun Sharma identified the arrested accused as Gurditt Singh, a native of Taran who was living in a rented accommodation in Kharar. Police suspect his involvement in several criminal cases and had received input that he was planning another firing incident.

Sharma said police teams cornered Singh, following which he allegedly opened fire at the police party. Police retaliated and apprehended him.

The operation was carried out by teams led by SP (City) Sarav Jindal, SP (Operations) Akashdeep Aulakh, Operation Cell in-charge Inspector Harinder Singh and CIA in-charge Inspector Pradeep Bajwa.

Police recovered two pistols from the spot and are probing the source. Sharma said Singh has shared information about two associates and teams have been sent to trace them.

"We have achieved a breakthrough. The accused has a role in some previous criminal incidents, and we have also received information about two of his associates. We will further investigate who his handlers are and where he procured the weapons from," Sharma said.
