M/s Guru Candles Prop: Mrs.Rina V R have availed loan facility from Indian Bank, Kunnamkulam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **M/s Guru Candles Prop: Mrs.Rina V R and Mr.Derby D Davis**, failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 05.06.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon **M/s Guru Candles Prop: Mrs.Rina V R and Mr.Derby D Davis** liable to the Bank to pay the amount due to the tune of **Rs 50,21,940/-(Rupees Fifty lakhs twenty-one thousand nine hundred forty only)** as on 15.05.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 05.06.2026

As **M/s Guru Candles Prop: Mrs.Rina V R** and Mr.Derby D failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **05.09.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
