

‘Technology delayed is technology denied’

NEW DELHI: IAF chief Air Chief Marshal A P Singh on Thursday pitched for achieving greater self-reliance in building unmanned aerial systems and other critical defence technologies, as he emphasised that “technology delayed is technology denied” and there is no point having something which comes after others have already got it. In his address at an event here, he also said there are “discussions happening between us and the Ministry of Civil Aviation, and other ministries involved” so that “we finally should be able to recognise a drone, whether it is a bona fide drone or a rogue drone”.

“We should be able to have no fratricide, in terms of we shooting down

our own drones or taking down something that is meant for us,” he said. At a workshop hosted here by the Society of Indian Defence Manufacturers (SIDM), and attended by various defence military and industry experts, the air chief marshal also spoke about integration of manned platforms and drones and other unmanned aerial systems (UAS), which would share the same airspace.

“Integration is very important. We have manned platforms and long-range vectors which will continue to use the same airspace where the drones are going to come in. I am talking about a whole range of drones, from a small micro or mini drone to a UAS which is like a full aircraft, but

unmanned. “Everybody is going to use the same airspace. So man, whether in the loop, on the loop,

at least in planning, in terms of control, feedback system, situational awareness, we need to know each other’s positions, and understand how an airspace is going to be used, whether it is procedural control or active control,” he said. The IAF chief added that if drones are to be miniaturised, and if their weights would go down, even the payloads to be used, whether a weapon or a camera or any other payload, also has to be miniaturised.

Strong performance

MUMBAI: JLR India has recorded its highest-ever first-quarter retail sales, delivering 1,665 units in Q1 FY27, marking an 11% year-on-year (YoY) growth. The company’s wholesales for the quarter stood at 1,694 units, reflecting a 4% YoY increase. Shah’s absence from Parliament ‘reeks of guilt’: Rahul

Order SC-monitored probe into NEET protest excesses.



NEW DELHI: Home Minister Amit Shah’s absence from Parliament “reeks of guilt”, Leader of Opposition Rahul Gandhi said on Thursday and again demanded a Supreme Court-monitored probe into the alleged police excesses against students during the NEET paper leak protests.

Gandhi also shared on X a video clip of police lathi-charging students.

“Students deserve justice. An independent SC-monitored high powered committee must be constituted to probe brutalities against our students,” he said on the social media site, referring to the crackdown on agitators by security forces during the July 20 Cockroach Janta Party-led protest march to Parliament and on student demonstra-

tors in other parts of the country. In another post, Gandhi asked why Shah is “so scared” of coming to Parliament and explaining the brutal violence against students.

“It reeks of guilt,” he added.

Later, in a Facebook post, Gandhi said, “Unless the system changes, paper leaks will not stop!”

Gandhi also on Wednesday demanded the sacking of Shah and the constitution of a Supreme Court-monitored probe into what he claimed was a “brutal attack” on protesting students and the use of pellet guns on them.
