e-AUCTION SALE NOTICE

Sale of Immovable Property Mortgaged to the Bank under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002

Whereas Shri. **AJAY KUMAR GOCHHI & Smt. SONU GOCHHI** had borrowed monies from **Indian Overseas Bank, Vashi Branch** against the mortgage of the immovable properties more fully described in the schedule hereunder and on upon classification of the account as NPA, the Bank has issued a demand notice under Section 13(2) of the SARFAESI Act, 2002 (Act) on **18.03.2025** calling upon the borrowers **Shri. AJAY KUMAR GOCHHI & Smt. SONU Gochhi** to pay the amount due to the Bank, being **Rs. 89,93,222.00 (Rupees Eighty Nine Lakhs Ninety Three Thousand Two Hundred Twenty Two Only)** as on **03.08.2026** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment within 60 days from the date of receipt of the said notice.

Whereas the borrowers & guarantors having failed to pay the amount dues in full to the Bank as called for in the said demand notice, the Bank has taken Physical possession of the secured assets more fully described in the schedule hereunder on **10.07.2026** under Section 13 (4) of the Act with the right to sell the same in "**As is where is**", "**As is what is**" and "**Whatever there is**" basis under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules, 2002 for realization of Bank's dues. The dues to the bank as on the date of taking possession was intimated as an amount of **Rs. 77,20,009.93 (Rupees Seventy Seven Lakhs Twenty Thousand Nine and Ninty Three Paise Only)** as on **18.03.2025** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **03.08.2026** works out to **Rs. 89,93,222.00 (Rupees Eighty Nine Lakhs Ninety Three Thousand Two Hundred Twenty Two Only)** after reckoning repayments, if any, amounting to NIL subsequent to the Bank issuing demand notice.

- (2) The intending Bidders/Purchasers are requested to register on portal <https://baanknet.com/eauction-psb/bidder-registration> using, their mobile number and email-ID further, they are requested to upload requisite KYC documents.
