

Committed to Curb Child Porn, Deepfakes, Meta Execs Tell Govt

New Delhi: Meta has committed to greater due diligence and measures to curb child pornography and deepfake content on Meta-owned social media platforms, sources said. Senior Meta officials led by global chief policy officer Joel Kaplan met electronics and information technology minister Ashwini Vaishnaw on Thursday to discuss the technical aspects of compliance with Indian laws, they added.

Technical meetings with Meta officials will continue and the company has been told it will have to follow the law of the land, officials stressed.

“Social media networks will have to comply with Indian laws. Companies cannot operate in India and cite laws of US or other foreign lands,” a government source said. He added the government would need to ascertain if platforms are responsible for the paid content they run.

The government will also evaluate the additional measures put in place by Meta, to see if they can effectively address the Centre’s concerns regarding content moderation, following Meta’s temporary restriction of the

PM’s post on Facebook last month, officials added. The Centre wants assurance from Meta that official profiles of prominent personalities in India would be ring-fenced.
