Mr.Ahamed Koya and others had availed home/plot loan facilities from Indian Bank, **Kallai Road Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. **Mr.ahamed koya and others** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **19.07.2021** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **Mr.Ahamed koya and others** liable to the Bank to pay the amount due to the tune of Rs.73,53,245/- (Rupees Seventy three lakhs fifty three thousand two hundred forty five only) as on **19.07.2021** with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated **19.07.2021**.

As **Mr.Ahamed Koya and others** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **04.10.2021** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

***As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002,15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.**

The amount due as on **01.07.2026** is **Rs.1,15,71,854/- (Rupees One crore fifteen lakhs seventy one thousand eight hundred fifty four only)** with further interest, costs, other charges and expenses thereon from **01.07.2026**.

The date of sale is fixed as 27.08.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **10.07.2026 to 26.08.2026** between **10.00 am to 4.00 pm.at Kallai Road Branch Mankavu junction Kozhikode kerala.**
