Terrorist hideout busted in Poonch, ammo seized

Sanjay Khajuria [New] Jammu: Security forces busted a terrorist hideout in a remote village in J&K's Poonch district, while joint teams carried out combing and search operations in Jammu's Akhnor sector and Kathua's Hirnarayan sector based on intelligence reports about suspicious activity of militants last Wednesday. Officials said the hideout, set up in a cave, was discovered during a joint search operation by the Army's Rashtriya Rifles and J&K Police in Bhorwala chok of Surankote tehsil Wednesday morning and two magazines of an AK assault rifle, 17 rounds of ammunition, and 17 rounds of from pistol ammunition were seized from the spot.

Around 2pm Tuesday, a suspected militant drove an allegedly stolen Indian air force car, and was spotted hovering over forward villages of Kathua's Hirnarayan sector. ISRF personnel tried to shoot it down but the UAV managed to return across the border. The area was searched but nothing suspicious was found, officials said.

Separately, the Army and J&K Police launched a combing operation in Jammu's Akhnor sector after a recent reported suspicious movement Tuesday. Meanwhile, separate combing and search operations were launched Tuesday in alleged suspicious activity was reported in two villages of Surankote sector.

CPI(M)-Liberation calls for lowering voting age to 16

Seeks To Empower The Younger Lot Among Gen Z

New Delhi: CPI (Marxist-Leninist) Liberation, whose student wing All India Students Association (AISA) was at the forefront of the recent Cordon-and-Search operation in Jammu's Akhnor sector, has demanded voting age to be lowered to 16 years from 18 to empower the younger lot among Gen Z.

"In the presentist Jammu, the world we see is a weakening of the younger lot to talk about the things that affect them and sought accountability. I feel they are ready, and therefore, I feel voting age should be lowered," CPI(M)-Liberation secretary Dipankar Bhattacharya said.

For Left parties like CPI(M)-L, the success of their student outfits in raising Gen Z's issues has provided them an opportunity to further their connection with youngsters to take up their concerns related to education, employment and accountability.

Highlighting RSS chief Mohan Bhagwat's event in Mumbai Thursday where he would address students aged 15 to 19 from across the country, Bhattacharya said, "RSS really wants to listen to India's Gen Z, they should lower voting age to 16."

"In today's digital era of information revolution, 16-year-olds are informed enough to make their political choices," he said in a statement.

"Mohan Bhagwat is all set to address 100 students aged 15 to 19 brought from 100 cities on August 6. Mumbai's Kirti Mukesh Ambekar Centre. The numbers are impressive, but what will be the outreach about?" he asked.

"RSS is reportedly desperate to reach out to Gen Z," Bhattacharya said, mentioning that the governing establishment had been "hostile to wards young protesters", citing PM Modi's recent video, which he said was "forcing 16-year-olds to slog through ideology."

He alleged that PM Narendra Modi has "already talked about 'culture shock', invoking patriarchal prejudices against India's 'misled daughters'."

Bhattacharya also plans to discuss the demand of reducing voting age with CPI(M) and INDIA bloc, along with AISA.

Voting age in India was brought down from 21 to 18 years through Constitution (Sixty-first Amendment) Act, 1986. While in some countries like Argentina, Austria, Brazil, East Timor, Greece and Indonesia it is 17.
