M/s Raja Fly Ash Bricks ,availed MSME Loan facility from Indian Bank, **Khanwa Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties . M/s Raja Fly Ash Bricks, failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **01.01.2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **M/s Raja Fly Ash Bricks, Raja Kumar S/o Suman Kumar, Dharmasila Devi W/o Late Gopal Prasad Singh**, liable to the Bank to pay the amount due to the tune of **₹ 86,20,630/- (Rupees Eighty Six Lakhs Twenty Thousand Six Hundred Thirty Only)** on **01.01.2026** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated **01.01.2026**.

As **M/s Raja Fly Ash Bricks** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **12.03.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. 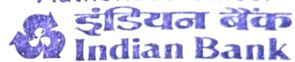
