M/s Manish Ranjan Traders availed MSME Loan facility from Indian Bank, Aurangabad M G Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Manish Ranjan Traders failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 10.03.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s Manish Ranjan Traders, Sri. Vikash Kumar Singh S/o Late Ravindra Prasad Singh, Smt. Kalawati Devi W/o Late Ravindra Prasad Singh, liable to the Bank to pay the amount due to the tune of ₹ 2,26,77,375/- (Rupees Two Crore Twenty Six Lakhs Seventy Seven thousand Three Hundreded Seventy Five Only) on 10.03.2026 with further interest, costs, other charges and expenses thereon.

As M/s Manish Ranjan Traders failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 14.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice The amount due ₹ 2,26,77,375/- (Rupees Two Crore Twenty Six Lakhs Seventy Seven thousand Three Hundreded Seventy Five Only) as on 10.03.2026 with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 10.03.2026.



Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 20.08.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **01.08.2026 to 19.08.2026 between 10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.
