Community kitchens to replace banner politics in Kerala hospitals

Kerala Health Minister K. M. Mani said on Saturday announced that Community Kitchens will be introduced in government hospitals to streamline the distribution of free meals to patients and their attendants, while ensuring transparency and eliminating political branding from the process.

The initiative will be placed at Alappuzha Medical College. Distribution of food packs under the banners or flags of political parties or organisations would no longer be permitted within hospital premises. Instead, all voluntary food distribution would be channelled through a unified Community Kitchen system," said Mani.

DRUGGED MILK, DEADLY SNAKE: Chilling UP murder Woman, lover among 4 held for conspiring to kill hubby

Four people, including a woman and her alleged lover, were arrested in Uttar Pradesh's Meerut district in connection with the death of her husband, who had died from a snakebite that turned out to be part of an elaborate plan to eliminate him, police said on Saturday.

REASON
Police said that the wife, Damini, had conspired with her lover and two others to kill Atul Panwar, who was treated as an obstacle to their romantic relationship, and to claim insurance money.

Panwar (35) and Damini had a love marriage in 2016, and they both lived in Hastnagar, where they ran the Krishna Kids Public School.

CONSPIRACY

A probe revealed that Damini was in frequent contact with a school driver named Tushar, alias Nikki, on mobile phone, police said. During interrogation, it was revealed that the two were in a relationship and hatched a plan to kill Panwar, they added.

Superintendent of Police (Rural) Abhijit Kumar said that Panwar was taken to a nearby Community Health Centre on Friday morning after allegedly being bitten by a snake at his house, and was later pronounced dead. Kumar said that a snake was found on his bed, but the family members suspected foul play, prompting the police to launch an investigation.
