**1. Nature and Object of Online Sale:**

**17. Bid Multiplier:**

The bidders shall increase their bids in multiples of the amount specified in the public sale notice/Terms and condition of Sale.

**18. Duration of Auction sale:**

- a. Online auction sale will start automatically on and at the time given in the public sale notice/Tender Document.
- b. Auction/Bidding time will initially be for specified period and if bidding continues, the bidding process will get automatically extended five minutes duration of each and kept open till the auction-sale concludes.
- c. **22. Default of Payment:**

- a. - g. No request for return of deposit either in part or full/cancellation of sale will be entertained.

**24. Return of EMD:**

- a. EMD of unsuccessful bidder/s will be returned by the Service Provider to the bank account details provided by him/her/them at the time of submission of bid.
- b. Unsuccessful bidders shall ensure return of their EMD and if not, immediately to contact the Authorised Officer of the Bank.

**25. Stay/Cancellation of Sale:**
