Smt. Daminee Sengar D/o Shri Dongar Singh_availed Home Loan and GMRA Loan facility from Indian Bank, New Palasia Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Smt. Daminee Sengar failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 09.04.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s). Smt. Daminee Sengar, liable to the Bank to pay the amount due to the tune of Rs. 40,25,395.14/- (Rupees Forty Lakhs Twenty Five Thousand Three hundred Ninety Five Rupees and fourteen Paise Only) as on 08.04.2026 with further interest, costs, other charges and expenses thereon. Borrower failed to make payment despite Demand Notice dated 09.04.2026.

As Smt. Daminee Sengar failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 17.06.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
