1. This has reference to recovery actions initiated against you under the provisions of the SARFAESI Act 2002.

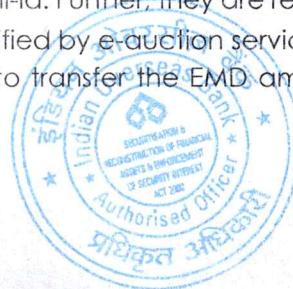

2. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using
