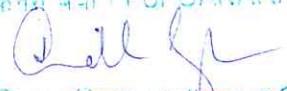

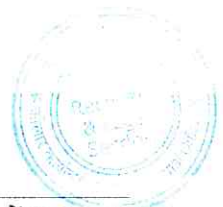
- c) The property will be sold for the price which is more than the Reserve Price and the participating bidders may improve their offer further during auction process.
