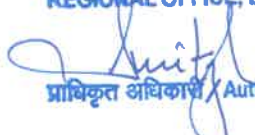
E-auction notice containing terms and conditions

1. The property(ies) will be sold by e-auction through the service provider **<https://BAANKNET.com/bidder-registration>** under the supervision of the Authorized Officer of the Bank.
