2. The Vehicle/P&M/Stock will be sold in AS is where is", As is what is", and Whatever there is" condition, including encumbrances if any. (There are no encumbrances to the knowledge of the Bank. For details of encumbrance, contact the undersigned before deposit of the Earnest Money Deposit (EMD) referred to para 18 below).

3. The Vehicle/P&M/Stock will be sold over & above the Reserve Price fixed by the Bank and minimum increment over the reserve price shall be **Rs. 10,000/- (Ten Thousand only)** for each property.

4. The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs.34400 (Thirty Four Thousand Four Hundred Rupees Only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" **28-07-2026 on or before 5:00PM.**

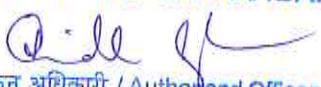
SPECIAL INSTRUCTION/CAUTION
