Terms and Conditions

1. The Sale will be done by the undersigned through e-auction platform provided at the Website <https://www.baanknet.com> on **29.08.2026 (10:30 AM to 06:00 PM)**. The intending Bidders/Purchasers are requested to register on portal (<https://www.baanknet.com/eauction-psb/bidder-registration>), using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his **EMD Wallet** well in advance before the auction time. In case EMD amount is not available in **EMD Wallet**, system will not allow to bid. The registration, verification of KYC documents and transfer of **EMD in wallet** must be completed well in advance, before auction. Bidders may give offers either for one or for all the properties. Only after having **sufficient EMD in his Wallet**, the interested bidder will be able to bid on the date of e-auction. Bidder's **Wallet** should have sufficient balance ($\geq$ EMD amount) at the time of bidding. In case of offers for more than one property bidders will have to deposit EMD for each property.

The successful bidder shall have to deposit 25% [Twenty Five Percent) of the bid amount, less EMD amount deposited through NEFT/RTGS in A/c 3173994015, IFSC-CBIN0280196, the same day or not later than next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale.
