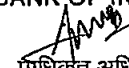

Since you failed to comply with the said notice within the period stipulated, the Authorized Officer, has taken Symbolic possession of the immovable secured assets under Section 13(4) of the Act read with Rule 8 of Security Interest (Enforcement) Rules, 2002. Possession notice dated 17.06.2026 issued by the Authorized Officer, as per Appendix IV to the Security Interest (Enforcement) Rules, 2002 was delivered to you and the same was also affixed to the properties mortgaged with the Secured Creditor, apart from publication of the same in newspapers.
2. As you have failed to clear the dues of the secured creditor, the immovable secured assets that have been taken possession of by the Authorized Officer, will be sold by holding public E-auction on 27.08.2026 (Thursday) from 12:00 Noon to 05:00 p.m. by inviting Bids from the public through online mode on <https://baanknet.com>.

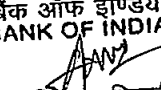
