

SC defers panel selection by UPSC for Odisha DGP's appt

New Delhi: The Supreme Court on Thursday asked Union Public Service Commission (UPSC) to defer the selection of a panel of three officers from which the Odisha govt was to choose the successor of present DGP Y B Khurania, who retires on Aug 16.

Appearing for applicant Jayant Das, senior advocate P Chidambaram told a bench of Chief Justice Surya Kant and Justices Joydip Bagchi and V Moha-

na that a certain ADGP was hurriedly promoted. DGP rank included the three names sent by Odisha govt to UPSC, which was against the DGP selection procedure laid down by SC in the three-decade-old Prakash Singh judgment.

When amicus curiae and senior advocate Raju Ramachandran said the matter required consideration, Odisha advocate general Pitambar Acharya said the state had followed the Prakash Singh guidelines

scrupulously and sent names of 11 DGP-rank police officers to UPSC for preparation of a panel of three most suitable officers.

"The complainant has seven criminal cases against him and is a habitual offender. He might have a certain axe to grind against some officers. There could be no breach of any procedure. We will present a clear picture before the court," Acharya said.

CJI Kant pointed out that none of the aggrieved officers who might have be-

en overlooked in the choice of 11 empaneled names have complained. UPSC, through senior advocate Hrishi-keesh Baruah, informed the court that the selection authority was meeting on Thursday itself. But the bench said it should not finalise the panel.

The bench asked Odisha govt to file its response to the application and posted the matter for hearing on Aug 18. This means Odisha would have to either ask Khurania to continue as DGP till further orders or appoint an ad hoc DGP.

HC sets aside UP prof's removal over CJP protest

Meerut: Setting aside the July 22 expulsion order of assistant professor at a govt-aided college in Bareilly over his participation in CJP's Jantar Mantar protest, Allahabad High Court has directed that petitioner Mohit Bhardwaj's matter be sent back to the college's

competent disciplinary authority for "review and fresh consideration".

The HC stated that "Ganna Upadak Mahavidyalaya failed to follow due process". It noted that while the college issued a notice to Bhardwaj and obtained his reply, the points raised in his response were

not given due consideration before the expulsion order was passed.

It directed the disciplinary authority to "afford an adequate opportunity of hearing to the petitioner, consider his reply and all relevant material on record" and thereafter pass a reasoned order in accordance with law and principles of natural justice, within

two months.

Bhardwaj said he was sacked for participating in the students' protest at Jantar Mantar on July 8. Reacting to the HC matter, Bhardwaj said he had faith in the judiciary and his objective in attending the protest was only to raise issues concerning the future of students and youth.

2013 riots: UP gets nod to withdraw case against 22

Muzaffarnagar: A special MP/MLA court in Muzaffarnagar has allowed UP govt to withdraw a 2013 criminal case, registered against 22 individuals, including former Union minister Sanjeev Balyan, former BJP MLA Sangheet Som, UP minister (independent charge) Kanit Dey, Agrawal, ex-minister Suresh Rana, ex-MLA Umesh Malik and former

BJP MP Kunwar Bharatendu Singh and activists, that followed the deadly communal riots.

It pertains to an incident on Aug 31, 2013, when a large crowd assembled at Nangla Mandaur grounds and held a "mela-panchayat", despite prohibitory orders under CrPc 144. People arrived in tractors, cars, two-wheelers and on foot. Allegations also included "provocative speeches against a particular community".

NEET racket: Two MBBS students held in Bihar

Patna: Two MBBS final year students at a medical college in Nalanda have been arrested in connection with irregularities in the NEET-UG-2026 exam and the retest, held on May 3 and June 21, respectively, Bihar Police said Thursday.

Ujjwal Raj, a resident of Mothari in East Champaran district, was arrested outside an exam centre in Patna on Aug 12 when he reached there to appear for his third year supplementary exam. Ravishankar alias Samrat, a resident of Shahjahanpur in Patna, was arrested outside the same exam centre on Aug 12.

Both the accused are students at Mahavir Institute of Medical Sciences in Purnapur.

The investigation by state police's economic offences unit (EOU) revealed a well-organised gang that allegedly used biometric manipulation and fake documents to arrange 'solvers' to appear for candidates in exchange for Rs 12-30 lakh per student. Four cases were registered for the exam irregularities.
