General Terms and Conditions of Public E-Auction

- 1) Auction/bidding shall be only through “Online Electronic Bidding” through the website <http://baanknet.com>. Bidders are advised to go through the website for detailed terms before taking part in the e-auction sale proceedings.
- 2) The property can be inspected, with Prior Appointment with Authorised Officer between 11.00 AM to 5.00 PM on 10.09.2026.
- 3) Sale is strictly subject to the terms and conditions mentioned in Public Notice of Sale published on **14.08.2026** (English and Bengali) also the terms and conditions mentioned hereunder in the E Auction Notice for Sale/offer / tender document to be submitted by the intending bidders.
- 4) Taxes if any on sale of the captioned property will be extra and has to be borne by the successful bidder.
- 5) The property will be sold in “As is where is basis”, “As is what is basis” and “Whatever there is basis”, including encumbrances, if any. No claims whatsoever shall be entertained by UVARCL under any eventuality.
- 6) The properties under auction can be inspected on the dates & time specified in the public notice. For any queries with regards to inspection of Properties or submission of tenders, kindly contact at the addresses(s) and / or telephone numbers mentioned in the notice.
- 7) Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through all online modes in bidders Global EMD Wallet. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as Cheques will not be accepted. Bidders, not depositing the required EMD in his Wallet, will not be allowed to participate in the e-auction. The Earnest Money Deposited shall not bear any interest. The EMD of the unsuccessful bidders will be returned without interest.
- 8) Offers that are not duly filled up or offers not accompanied by the EMD equal to 10% of reserve price or offers received after the stipulated date and time will not be considered / treated as valid offer, and accordingly shall be rejected. The Earnest Money Deposit shall not carry any interest.

However, the undersigned has the absolute discretion to allow inter-se bidding if deemed necessary, which will take place at the said place, date and time.
