The sale will be of the properties of the borrower/Guarantors above named and there are no known liabilities, encumbrances and claims attached to the said properties.

No persons other than the bidders themselves or their duly authorized representative shall be allowed to participate in the E-auction / inter-se bidding/ sale proceedings. No officer or other person, having any duty to perform in connection with this sale shall, however, directly or indirectly bid for, acquire or attempt to acquire any interest in the property being sold.

The sale shall be subject to the conditions prescribed in the Security Interest (Enforcement) Rules 2002 and the conditions published in sale notice and to the following conditions:



1. The particulars specified in the Schedule herein below have been stated to the best of the information of the undersigned, but the undersigned shall not be answerable for any error, misstatement or omission in this proclamation.
2. The Authorised Officer has absolute right to accept/ reject any tender/bid or adjourn/ postpone the sale without assigning any reason there for;
3. **Preference shall be given to successful bidder of Property No.1 over successful bidder of Property No.2.**
4. The Sale will be done by the undersigned through e-auction platform provided at the Website <http://baanknet.com>. on 18.09.2026 (4:00 PM to 5:00 PM). The intending Bidders/Purchasers are requested to register on portal (<http://baanknet.com>) using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet well in advance before the auction time. In case EMD amount is not available in Global EMD Wallet, system will not allow to bid. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction. Bidders may give offers either for one or for all the properties. Only after having sufficient EMD in his Wallet, the interested bidder will be able to bid on the date of e-auction. Bidder's Global Wallet should have sufficient balance ($\geq$ EMD amount) at the time of bidding. In case of offers for more than one property bidders will have to deposit EMD for each property.
5. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through all online modes in bidders Global EMD Wallet. NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as Cheques will not be accepted. Bidders, not depositing the required EMD in his Wallet, will not be allowed to participate in the e-auction. The Earnest Money Deposited shall not bear any interest. The EMD of the unsuccessful bidders will be returned without interest.

8. The bid amount shall be equal to or higher than the Reserve Price. The above-mentioned properties shall not be sold below the Reserve Price mentioned above. During the e-auction, bidders shall be permitted to enhance their bids over and above the prevailing highest bid, subject to a **minimum incremental increase of ₹50,00,000/- (Rupees Fifty lakhs Only)** for property no.1 and Rs.1 ,00,000 (Rupees One Lakh Only) for property no.2 or in multiples thereof. No bid below the Reserve Price shall be accepted, and any such bid shall be rejected. An unlimited extension of **10 (Ten) minutes** shall be provided if a bid is received during the last 10 (Ten) minutes of the e-auction. Default of Payment: Default of payment of 25% of bid amount (less EMD) on the same day or the next Working day as stated above and/or 75% of balance bid amount within the stipulated time shall render automatic cancellation of sale without any notice. 14. Payment of sale consideration by the successful bidder to UVARCL will be subject to TDS under Section 194-1A of Income Tax Act 1961 and TDS is to be made by the successful bidder only at the time of deposit of remaining 75% of the bid amount.
15. On receipt of the entire sale consideration, the Authorized officer shall issue the Sale Certificate as per Rules. The purchaser shall bear the stamp duties, including those of Sale certificate, registration charges, all statutory dues payable to Government/any authority, Taxes, GST and rates and outgoing both existing and future relating to properties.
16. No request for inclusion/substitution of names, other than those mentioned in the bid, in the sale certificate will be entertained. The Sale certificate will be issued only in the name of the successful bidder.
17. The Sale Certificate will not be issued pending operation of any stay/injunction/restraint order passed by the DRT/DRAT/High Court or any other court against the issue of Sale Certificate. Further no interest will be paid in the amount deposited during this period. The deposit made by the successful bidder pending execution of Sale Certificate, will be kept in non-interest-bearing deposit account. No request for return of deposit either in part or full/cancellation of sale will be entertained. In case of stay of further proceedings by DRT/DRAT/High Court or any other court, the auction may either be deferred or cancelled and persons participating in the sale shall have no right to claim damages, compensation of cost for such postponement or cancellation.
