M/s. Best Computer Solutions (Prop. Mr. Asad Anwar Sayed) availed MSME loan facility from Indian Bank, Borivali West Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s. Best Computers (Prop. Mr. Asad Anwar Sayed)** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 02/11/2017 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) **M/s. Best Computer Solutions (Prop. Mr. Asad Anwar Sayed)** liable to the Bank to pay the amount due to the tune of **Rs. 99,72,986.00 (Rupees Ninety-Nine Lac Seventy-Two Thousand Nine hundred and Eighty-Six Only)** as on 01/11/2017 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 02/11/2017.

As **M/s. Best Computers Solutions (Prop. Mr. Asad Anwar Sayed)** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 29/12/2018 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.



The amount due as on Rs. 99,72,986.00 (Rupees Ninety-Nine Lac Seventy-Two Thousand Nine hundred and Eighty-Six Only) with further interest, costs, other charges and expenses thereon from 01/07/2017.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.08.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense on 21.08.2026 between 10.00 am to 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
