

Fire station project fails to take off due to non-availability of land

MORE than a year after the State Government sanctioned Rs 10.44 crore for a new fire station in Belagavi, the project is yet to take off as authorities continue to search for a suitable site.

The delay has revived the long-pending demand for a dedicated fire station in the northern part of the city, which has witnessed rapid urbanisation, expansion of residential areas, growth of commercial establishments and increasing traffic congestion.

A team of officials has been searching for suitable land in north Belagavi, but a site is yet to be finalised, fire department officials said. The delay in identifying land has consequently held up further work on the project. At present, the city largely depends on the main fire station near the railway overbridge in the Maratha Mandir area. The office of the District Fire Officer is also located on the premises.

The station caters to emergencies not only within Belagavi city but also in several surrounding villages, placing considerable pressure on its resources.

Belagavi has expanded considerably in recent years, with new residential layouts, commercial complexes

and industrial establishments coming up across the city. The northern part, in particular, has seen substantial development.

Narrow roads, densely populated neighbourhoods and frequent traffic congestion can delay fire tenders from reaching emergency spots. In the event of a fire, even a few minutes' delay can allow the blaze to spread and increase the risk to lives and property.

A fire station near Suvarna Vidhana Soudha at Halaga and another operating on the premises of a private company in Honga provide additional support. However, officials and residents point out that these facilities cannot substitute for a dedicated civil fire station within the northern part of the city.

'No room for further delay'

Although the Cabinet has already approved the required funds, the absence of a suitable site remains the biggest hurdle. Once land is identified, construction and installation of firefighting equipment and other infrastructure will take additional time. Citizens are now urging the authorities to expedite the land identification process and commence construction without further delay. With Belagavi's population and built-up areas continuing to expand, residents say a modern, fully equipped fire station in the northern part of the city is no longer merely a demand for better infrastructure, but an essential requirement for effective emergency response and public safety.

2 children injured in stray dog attacks

Vijayapura: Two children were injured in separate stray dog attacks in Indi town of Vijayapura district, triggering concern among residents and renewed demands for effective measures to control the growing stray dog menace. In the first incident, a nine-year-old girl, Prerana Gowli, was attacked by a stray dog while she was playing in front of her house. The dog reportedly attacked her suddenly, causing serious injuries to the lower part of her face and around her eyes. She was shifted to the Indi Taluk Hospital, where she is undergoing treatment. In another incident reported from Karim Nagar in Indi town, a five-year-old boy, Taimur Makandar, was bitten by a stray dog. The boy was reportedly on his way to a shop when the dog attacked him, injuring his hand. He was also taken to the Indi Taluka Hospital for treatment. The two incidents have sparked concern among residents, particularly parents, over the safety of children in residential areas. Residents have urged the civic authorities to take immediate and effective steps to control the stray dog population and prevent further attacks. ENS
