

Family of landslide victims receives ₹15L compensation

MINISTER Shivaraj Tangadagi visited the family of the victims from Kakkargol village in Karatagi taluk of Koppal district, who died in the landslide tragedy at Thirthahalli in Shivamogga district, and offered his condolences.

The Rs 15 lakh compensation released from the disaster management account of the Shivamogga tahsildar was equally divided between the two children of the de-

ceased. The minister, in the presence of Gandajji Gouramma, handed over receipts confirming the deposit of Rs 7.50 lakh each into the bank accounts of the deceased's daughters, Divya and Mahalakshmi.

Divya, aged 7, is studying in class 1, while 9-year-old Mahalakshmi is studying in class 3. The family members appealed to the minister to make arrangements for their education.

The minister said that if the family agreed, the girls could be accom-

modated at a children's home, where all facilities required for their education would be provided. If the family did not agree, arrangements would be made to provide both Divya and Mahalakshmi financial assistance of Rs 4,000 each per month for three years under a sponsorship scheme, he said.

The villagers also requested that a house be provided to the deceased's family, who are poor. The minister assured them that he would instruct the panchayat authorities to make arrangements for a house.

Hanumanth, son of Fakeerappa of Kakkargol, and Amrutha, wife of Ramanna of Mukkunda, who had gone to Thirthahalli for work and were seriously injured in the accident, met the minister and sought compensation. The minister said he has instructed the Deputy Commissioner to make arrangements for reimbursement of their medical expenses and other compensation as per the rules.

Three members of the same family from Kakkargol village in Karatagi taluk were killed in a landslide caused by heavy rain at Indira Nagar in Thirthahalli taluk.

The Shivamogga Deputy Commissioner had directed that a total compensation of Rs 15 lakh, at Rs 5 lakh each to the legal heirs of the deceased, be distributed from the disaster management account through the Shivamogga tahsildar.
