

SC directs Centre to appoint nomenclature officer, assist families of those killed

The bench was hearing a plea pertaining to Indian nationals recruited into the Russian military after being allegedly duped by travel agents.

The bench heard submissions of the counsel for the petitioner and Additional Solicitor General Aishwarya Bhati, on behalf of the Centre and passed a slew of directions.

NEW DELHI: The Supreme Court on Friday directed the Centre to appoint a nodal officer in the external affairs ministry to coordinate with the families of those who have died, gone missing, or suffered injuries while fighting in the Russia-Ukraine war.

A bench comprising Chief Justice Surya Kant and Justices Joydip Bagchi and V Mohana also directed the Ministry of External Affairs (MEA) to facilitate DNA matching of family members with the mortal remains.



The bench was hearing a plea pertaining to Indian nationals recruited into the Russian military after being allegedly duped by travel agents. The plea seeks return of mortal remains, compensation and a coordinated mechanism for affected families.

"The Ministry of External Affairs (MEA) shall notify an official as the nodal officer whose details and contact number be shared with the family members of Indian nationals who had gone to Russia... and died

or injured," the bench said. It asked the MEA to arrange for the DNA tests of family members of the dead and upon matching, ensure handing over of the mortal remains.

It also asked the ministry to ensure that bereaved families are provided with the details of documents needed for claiming compensation from the Russian government. It directed the MEA to provide all relevant information and updates in vernacular language. The bench asked the ministry to lead expeditiously

It claimed that diplomatic, consular and humanitarian efforts to trace missing Indians, secure their release and facilitate repatriation remain ongoing.

with the cases pertaining to handing over the mortal remains to the families for conducting last rites.

It also directed the National Legal Services Authority (NALSA) and state legal services to extend assistance to the families in securing the mortal remains of their relatives and pursuing compensation claims.

It further directed the government to ensure that families get the receipt and other information related to compensation and delivery of mortal remains. The additional solicitor general

said that according to latest information, 219 people had fought the war and 51 have died. She said 20 people have been brought back.

The bench, in its order, noted that over two hundred people, mostly handed over from Rajasthan, Haryana and Punjab, had gone to Russia in 2024-25 for working in different sectors including hospital. The bench said it was alleged that they were duped by travel agents and their passport and other documents were seized on reaching Russia. It further noted that they were enrolled in the Russian Army and sent to war zones.

"Unfortunately, many lost their lives and after due verification, mortal remains of many have been brought to India," the bench said, adding that many families are yet to be paid the compensation.

a resolution on Suspension of Operations (SoO)," Imagi Meira president Sujata Thokkom told reporters.

She said members of the House, irrespective of their affiliation to the ruling or opposition parties, should come together for the session.

"So far, no decision could be taken from the assembly to save the state," she said. In Kangpokpi district, hundreds of internally displaced persons (IDPs) staged a protest demanding the immediate release of pending funds through Direct Ben-

efit Transfers (DBT) meant for the displaced people in the district.

The protest was organised by the Kangpokpi District Internally Displaced Welfare Committee, which said thousands of people have been affected due to delays in the release of DBT assistance for July. In a statement, the committee said the DBT assistance is primarily used for paying school fees and admission charges of displaced children, purchasing essential food items and medicines, besides meeting other household expenses.

GODDA Three arrested, 18 stolen motorcycles recovered

Three persons were arrested and 18 stolen motorcycles recovered in Jharkhand's Godda district, police said on Friday.

The arrests were made during an investigation into a series of motorcycle theft cases registered at different police stations in the district, they said.

Godda SDPO Akash Bhardwaj said the accused were identified on the basis of technical surveillance and human intelligence. "During interrogation, the accused confessed that they used to replace the original registration numbers with fake ones and scratch the chassis and engine numbers to conceal the identity of the stolen motorcycles before selling them at throwaway prices," Bhardwaj told PTI. He said the trio also admitted to storing unused motorcycles at a garage until buyers were found.

One of the arrested persons has previous criminal antecedents in similar offences, while all three are residents of different parts of Godda district, the SDPO said. An FIR has been registered against the accused at the Town police station, and further investigation is underway.
