Ms.Sidagam Venkata Satya Durga Anasuya Kumari availed home loan limit of Rs.25,00,000/-, facilities from Indian Bank, Kavitam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Ms.Sidagam Venkata Satya Durga Anasuya Kumari** failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated **18.04.2024**.

As **Ms.Sidagam Venkata Satya Durga Anasuya Kumari** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **08.07.2024**, after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
