Mr.Nedunuri Ramesh Kumar & Mr. Nedunuri Suresh Kumar availed home loan limit of Rs.24,52,000/-, facilities from Indian Bank, Kavitam Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Nedunuri Ramesh Kumar & Mr. Nedunuri Suresh Kumar** failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated **15.04.2024**.

As **Mr. Nedunuri Ramesh Kumar & Mr. Nedunuri Suresh Kumar** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **22.07.2024**, after complying with all legal formalities.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.
