ment Agency Project Officer  
Subham Nokwal told *The Hin-  
du* that as many as four is-  
lands were affected and 1,683  
people were evacuated in  
Andhra Pradesh on Saturday.  
"The evacuation drive is con-  
tinuing. We have opened 11 re-  
lief camps out of the 118 iden-  
tified for flood relief. As many  
as 110 pregnant women have  
been shifted to nearby gov-  
ernment hospitals," he said.
