Mr. Sk Chalil availed Home Loan from Indian Bank, Dewandighi Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Sk Chalil, failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 25.03.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) liable to the Bank to pay the amount due to the tune of **Rs.572167/- (Rupees Five Lakhs Seventy Two Thousand One Hundred and Sixty Seven only)** as on 25.03.2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 25.03.2026.

Mr. Sk Chalil failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 17.06.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:
