Notice of sale under Rule 8(6) read with 9(1) of The Security Interest (Enforcement Rules) 2002 under The Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002

Mrs. Pranjali Bhalchandra Shinde availed Term loan facility from Indian Bank, CBD Belapur the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mrs. Pranjali Bhalchandra Shinde failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 13.06.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) Mrs. Pranjali Bhalchandra Shinde liable to the Bank to pay the amount due to the tune of Rs.1723729.00/- (Rupees Seventeen lakh twenty three thousand seven hundred twenty nine as per demand notice dated 13.06.2024 with total amount of 2162804.00.00 (Rupees Twenty one lakh sixty two thousand eight hundred four Only) with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 13.06.2024

As Mrs. Pranjali Bhalchandra Shinde failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days' notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 10.08.2026 is Rs 2196350.00.00.00 (Rupees Twenty-one lakh Ninty- six thousand three hundred fifty Only) with further interest, costs, other charges and expenses thereon from 11.08.2026
