Sub: Loan account – M/s Samind Sudhakar Jadhav (A/c No Term Loan–6456812647 with Indian Bank, Dombiveli East

M/s Samind Sudhakar Jadhav availed Term Loan facility from Indian Bank, Dombiveli East the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as “the Properties”. M/s Samind Sudhakar Jadhav failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 09.01.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) Mr. Samind Sudhakar Jadhav liable to the Bank to pay the amount due to the tune of Rs. 1984118.00/- (Rupees Nineteen lakh eighty-four thousand one hundred eighteen Only) as per demand notice dated 09.01.2023 with total amount of 2785901.00 (Rupees Twenty-Seven lakh eighty five thousand nine hundred one Only) with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notices dated 09.01.2023

As Samind Sudhakar Jadhav failed to make payment despite Demand Notices, the Authorized Officer took possession of the schedule mentioned properties under the Act on 26.04.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with

the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 10.08.2026 is Rs. 2837443.00 (Rupees Twenty-eight Lakh thirty-seven thousand four hundred forty three Only) with further interest, costs, other charges and expenses thereon from 11.08.2026

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.08.2026 which would be by e-auction mode.

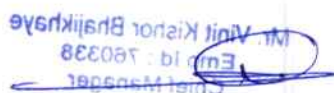
The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
