M/S BHARATH MOTORS, M/S. BHARATH WHEELS, M/S BHARATH CAR ASSURED, Mr Prakash Kumar has availed credit facilities from Indian Bank, Marthandam Branch, the repayment of which are secured by mortgage of schedule mentioned property, hereinafter referred to as 'The Properties'. M/S BHARATH MOTORS, M/S. BHARATH WHEELS, M/S BHARATH CAR ASSURED, Mr Prakash Kumar failed to pay the outstanding to the bank.
