Mrs. Seema W/o Devendra Singh & Mr. Devendra Singh S/O Badri Prasad (Borrower) availed Home Loan facility from Indian Bank (Erstwhile Allahabad Bank) FODS Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mrs. Seema W/o Devendra Singh & Mr. Devendra Singh S/O Badri Prasad** failed to pay the outstanding dues to the Bank.
