Cauvery row sparks political tug-of-war

On Saturday, DMK President MK Stalin criticized CM Vijay over his approach to the Cauvery issue.

CHENNAI: DMK President M K Stalin on Saturday alleged that Tamil Nadu Chief Minister C Joseph Vijay had become “isolated” over the Cauvery water dispute after attempting to visit Karnataka despite opposition from political parties, farmers’ organizations, and other stakeholders in the state.

Stalin questioned whether Vijay would convene an all-party meeting on the issue and urged the Chief Minister to consult political leaders, farmers' representatives, and experts before taking any further steps regarding the Cauvery dispute.

In a statement, Stalin said that leaders of various parties and farmers'

BHUBANESWAR: In view of consistent rain during the monsoon and to ensure safe and uninterrupted train operations, Divisional Railway Manager (DRM), Rayagada, Amitabh Singhal conducted an extensive inspection of vulnerable railway sections under the Rayagada Division. The inspection focused on critical safety aspects in ghat sections, including areas susceptible to heavy rainfall, water logging, rock fall and soil erosion.

During the inspection, Singhal reviewed the preparedness of Railway staff and closely examined the condition of vulnerable cuttings, tunnels, drainage systems, and track infrastructure. He emphasized that safety remains the highest priority of the Division and directed officials to maintain continuous monitoring of all sensitive locations during the monsoon season.

associations in Tamil Nadu had already cautioned Vijay that discussions with Karnataka on the proposed Mekedatu project would not yield any positive outcome. Despite these warnings, Vijay reportedly sent representatives to Karnataka, which Stalin criticized sarcastically, saying it appeared as though the Chief Minister believed he could return with the Cauvery river itself.

Stalin stated that Karnataka's approach towards Tamil Nadu had repeatedly shown a tendency to treat the state merely as a recipient of surplus Cauvery water. He said Tamil Nadu's past experiences indicated that legal measures were the most effective way to protect the state's water rights, as Karnataka had often refused to release water despite official directions.
