In Compliance with the MCA Circulars, the Company has completed the dispatch of the Postal Ballot Notice, by electronic means only, today i.e. on Friday, 7th August, 2026 to those Shareholders of the Company whose names appeared in the Register of Shareholders/List of Beneficial Owner as maintained by the Company/ Depositories, respectively as at close of business hours on Friday, 31st July, 2026 (the Cut-off date) and whose e-mail address are registered with the Company/Depositories. The Postal Ballot Notice is available on the website of the Company i.e. at <https://smmahindra.com/> and on the websites of stock exchanges viz. BSE and NSE at www.bseindia.com and www.nseindia.com respectively and on the website of NSDL at www.evoting.nsdl.com

Members whose names appeared on the Register of Shareholders/List of Beneficial Owners as on the Cut-off date are entitled to vote on the resolutions as set forth in the Postal Ballot notice. The voting rights of the Members shall be reckoned in proportion to the paid-up equity shares held by them as on the Cut-off date. A person who is not a Member as on the cut-off date shall treat the Postal Ballot Notice for information purpose only.

In compliance with the MCA circulars, the Company has provided the remote e-voting facility to its Shareholders, to enable them to cast their votes electronically instead of submitting the physical Postal Ballot form. The communication of the assent or dissent of the Shareholders would take place only through the remote e-voting system. For this purpose, the Company has taken the services of National Securities Depository Limited (NSDL) for facilitating remote e-voting to enable the Shareholders to cast their vote electronically only.

The detailed procedure and instructions for remote e-voting are enumerated in the Postal Ballot Notice. Remote e-voting shall commence on Saturday, 8th August, 2026 at 9.00 A.M (IST), and shall end on Sunday, 6th September, 2026 at 5.00 P.M (IST). The remote e-voting facility will be disabled for voting by NSDL upon expiry of the aforesaid voting period.

Mr. Kanwaljit Singh, a Practicing Company Secretary, and failing him Mr. Ajay K. Arora, Practicing Company Secretary, has been appointed as the scrutinizer for conducting the Postal Ballot in a fair and transparent manner. The results of the Postal Ballot, together with the Scrutinizer's report, will be announced within two working days from the conclusion of the e-voting period and will also be simultaneously displayed on the notice board of the Company at its Registered Office and Corporate Office. The results will also be uploaded on the website of the Company, website of NSDL and will also be intimated to NSE and BSE.
