

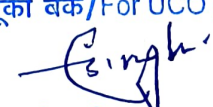

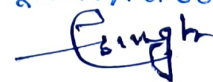

- 3) The auction sale will be "online e-auction" bidding through website <https://BAANKNET.com/education-psb/home>
- 4) Date & time of Inspection of Property : 10.09.2026 – 10: 00 A.M to 5: 00 P.M
- 3) Date and time of auction: 11.09.2026 between 11:00 A.M. to 05:00 P.M. as per (IST)
- 4) Auction would be conducted for an initial period of 360 minutes followed by unlimited extensions of 10 minutes each, in case a valid bid is received in last 10 minutes.
- 5) Auction would commence at Reserve price, as mentioned above. Bidders shall improve their offers **In multiples of Rs. 10,000/- (Ten Thousand only)**
