1. The property(ies) will be sold by e-auction through the service provider <https://baanknet.com> under the supervision of the of the Authorized Officer of the Bank.
2. The intending Bidders/Purchasers are requested to register on e-Auction portal <https://baanknet.com/bidder-registration> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider, the intending Bidders/Purchasers have to transfer the EMD amount using online mode in his/her Global EMD Wallet one day prior to the e-Auction date & time in the portal. **The last date for payment of EMD is 09.09.2026 till 10:00 PM.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
