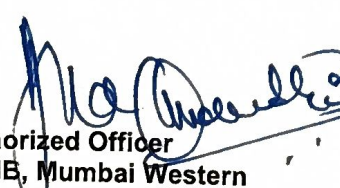
PROCLAMATION OF SALE

Whereas under section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, a notice dated 26.05.2026 for the recovery of sum of Rs. 72,59,988.40/- plus further interest and charges on other loans from date of NPA 'was issued to the Mrs. Arati Baban Pawar and Mrs. Sulochana Baban Pawar and whereas the secured assets mentioned in the schedule were taken in symbolic possession on 12.08.2026. Whereas the sale of secured asset is to be made to recover the secured debt. And whereas on the 06.10.2026 (the date fixed for the sale), there will be due under the secured debt, a sum of Rs. 72,59,988.40/- plus further costs and interest plus charge on other loans minus recovery. Notice is hereby given that, in the absence of any postponement / discontinuance of the sale, the said property shall be sold by public auction at 11:00 AM on the said the 06th of October 2026 at Mumbai of the property of the borrower above named and the liabilities and claims attaching to the said property, so far as they have been ascertained, are those specified in the Schedule against each lot. The property will be put up for sale in the lots specified in the Schedule. If the amount to be realized by sale is satisfied by the sale of a portion of the property, the sale shall be immediately stopped with respect to the remainder.
