ALLOTMENT/MAPPING OF LEGAL CASES PERTAINING TO AUCA, AUCA DROPPED/REMOVAL AND CLOSED ACCOUNTS

Reference is invited to the email dated 13.08.2026 received from SAMRO Hyderabad, wherein the Branches have been advised to ensure that:

1. all AUCA and AUCA Dropped/Removal cases are allotted to the CCO/CLO;
