7. The amount by which the biddings are to be increased shall be Rs.1,00,000/- for Schedule 'A', 'B', 'C' & 'D' in the event of any dispute arising as to the amount of bid, or as to the bidder, the lot shall at once be again put up to auction.
8. The unsuccessful bidder shall take EMD directly from the Office of Recovery Officer, DRT, Ranchi immediately on closure of the e-auction sale proceeds.
