Mr. Amol Dattatray lad and Mrs. Amita Amol Lad availed loan facility from Indian Bank, Ratnagiri TRP Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Amol Dattatray lad and Mrs. Amita Amol Lad failed to pay the outstanding dues to the Bank. 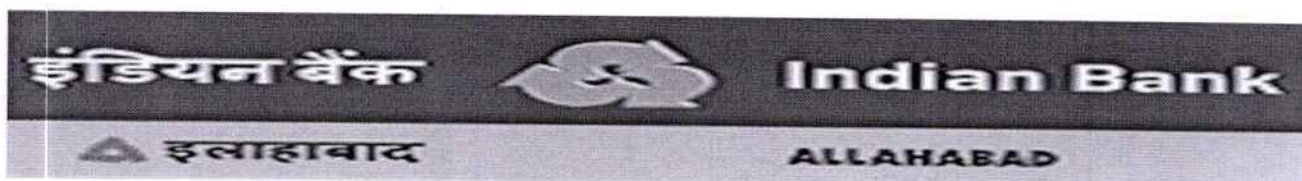
