Santosh Maruti Utture and Samiksha Santosh Utture availed Loan facility from Indian Bank, Ratnagiri TRP Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Santosh Maruti Utture and Samiksha Santosh Utture failed to pay the outstanding dues to the Bank. Therefore Demand Notice dated 15.05.2023 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) Santosh Maruti Utture and Samiksha Santosh Utture liable to the Bank to pay the amount due to the tune of amount of Rs. 10,90,985.00 (Rupees Ten Lakhs Ninety Thousand Nine Hundred Eighty Five Only) as on 15/05/2023 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 15.05.2023.

As Santosh Maruti Utture and Samiksha Santosh Utture failed to make payment despite Demand Notice, the Authorized Officer took symbolic possession of the schedule mentioned properties under the Act on 03.11.2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 19.02.2026 is Rs. 14,89,100.00 /- (Rupees Fourteen Lakhs Eighty Nine Thousand One Hundred Only) with further interest, costs, other charges and expenses thereon from 20.02.2026.

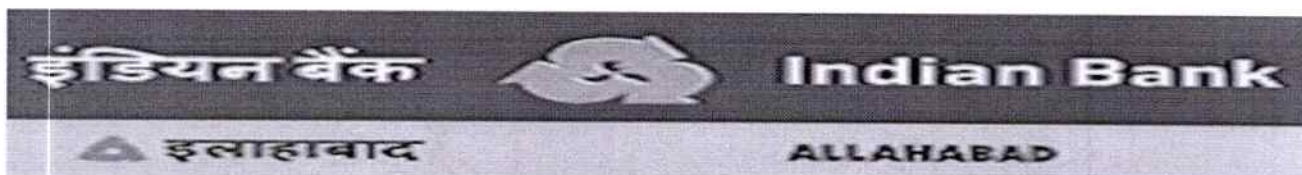
