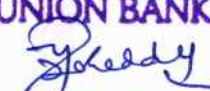

(b) In case of bidding, the bid increment shall not be less than Rs.3,80,000/-(Rupees Three Lakhs Eighty Thousand only) in excess of highest bid amount or the immediately preceding bid, as the case may be with multiple increment value of Rs.3,80,000/-(Rupees Three Lakhs Eighty Thousand only)

(c) In case of bidding, the bid increment shall not be less than Rs.1,40,000/-(Rupees One Lakh Forty Thousand only) in excess of highest bid amount or the immediately preceding bid, as the case may be with multiple increment value of Rs.1,40,000/-(Rupees One Lakh Forty Thousand only)

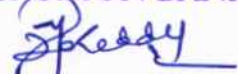

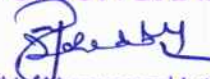

16.
