1. The Sale will be done by the undersigned through e-auction platform provided at the Website <https://www.baanknet.com> on **15.09.2026 (10:30 AM to 16:30 PM)**. The intending Bidders/Purchasers are requested to register on (<https://www.baanknet.com/eauction-psb/bidder-registration>), using their mobile number and email-id. Further, they are requested to upload requisite KYC documents or the buyer can login through the Digi Locker Details. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using online mode in his **EMD Wallet** well in advance before the auction time. In case EMD amount is not available in **EMD Wallet**, system will not allow to bid. The registration, verification of KYC documents and transfer of **EMD in wallet** must be completed well in advance, before auction. Bidders may give offers either for one or for all the properties. Only after having **sufficient EMD in his Wallet**, the interested bidder will be able to bid on the date of e-auction.
