

Gujarat Police seizes phones, laptops from journalist Ravi Nair's Delhi home

A TEAM of the Gujarat Police on Monday searched the Delhi home of independent journalist Ravi Nair and seized three laptops, two phones and an iPad. The seized devices allegedly included those belonging to Nair's son and a colleague of the journalist's.

Nair is facing charges of defamation and forgery in Ahmedabad following a complaint over a news report and posts on X about the Adani Group.

On August 11, Gujarat High Court had refused to quash an FIR registered by the Ahmedabad Detection of Crime Branch (DCB) against Nair on May 29 this year over an article published in *The Washington Post*, which had alleged that Life Insurance Corporation of India (LIC) had been directed to make large investments in Adani Group companies.

The complainant in the case is Dushyant Vijaybhai Joshi, representing Adani Ports and Special Economic Zones Ltd (APSEZ). The HC held that the allegations in the FIR were materially different from an earlier private defamation complaint, and prima facie indicated cognizable offences that required investigation. The Gujarat Police team was accompanied by personnel from the Delhi Police during the search. Nair was not at home at the time.

A senior official of the Gujarat Police said that a unit of the force had seized the electronic devices from Nair's Delhi residence as part of their investigation into the FIR following the HC's order last week, based on a warrant issued by a Magistrate Court in Ahmedabad.

Nair's colleague told *The Indian Express* that she was at Nair's residence with his son when the police team arrived at 2.40 pm on Monday. "The officials showed us a search warrant and collected some gadgets. There were three laptops, two old phones that were kept in a cupboard, and one iPad. The laptops belonged to me and Ravi's son, who works at a software company," she said.

She said the search was recorded by a member of the police team. The officials also asked them to sign some documents before leaving around 6.40 pm. She said Nair had been cooperating with investigators. "However, neither his son nor I are accused in any case. I don't know why they took away our devices".

On August 11, Justice M R Mendgdey of the HC rejected the journalist's contention that the FIR amounted to an abuse of the legal process.

The FIR, lodged under Sections 318(4), 336(2), 336(4) and 340(2) of the Bharatiya Nyaya Sanhita 2023 (BNS), relates to an article published in *The Washington Post* on October 24, 2025. These sections deal with cheating; altering or destroying a valuable security; forgery, which is intended, or known likely, to harm the reputation of a party; and fraudulently or dishonestly using a forged document or electronic record as genuine. The FIR said the article had alleged that the government and LIC had directed investments of large funds into Adani Group companies.

Naidu: 34% quota for Backward Classes in local body polls

Hyderabad: The Andhra Pradesh government has announced 34% reservation for Backward Classes (BC) communities in the local body polls, which are likely to be held later this year. Apprising the Legislative Assembly in Amaravati of the Cabinet's decisions on Tuesday, Chief Minister N Chandrababu Naidu said while 34% reservation will be given to BCs in rural local bodies, they will have 33.33% quota in urban local bodies. Besides, election of Mayors and Municipal Chairpersons in urban local bodies will be conducted through direct polls.

Naidu said that the TDP-led NDA government is fulfilling its 2024 election promise of increasing the BC reservation in local bodies from 20% to 34%.

He said the issue about correcting the injustice done to BCs under the previous government. ENS

PM CARES sees drop in donations

Total balance at an all-time high

TOTAL CONTRIBUTIONS to the Prime Minister's Citizen Assistance and Relief in Emergency Situations Fund (PM CARES Fund) fell to Rs 479.96 crore in financial year 2024-25. Its closing balance, however, touched an all-time high of Rs 8,452.06 crore as the spending, too, fell to a five-year low of Rs 87.85 lakh.

According to the latest Receipt and Payment Accounts (Audited) statement available on the PM CARES Fund portal, domestic donations accounted for Rs 479.04 crore of the total contributions while foreign donations added up to about Rs 92

lakh. The Fund also received Rs 475.14 crore as interest income (Rs 469.37 crore from fixed deposits, Rs 5.76 crore from regular accounts), about Rs 13.49 lakh as refund of tax deducted at source (TDS) on interest on fixed deposits from banks, and Rs 324.65 crore as "refund from implementing agencies".

Meanwhile, the total spending fell to Rs 87.85 lakh, includ-

ing Rs 87.84 lakh on the PM CARES for Children Scheme and Rs 451 as bank charges and SMS charges. The total spending was Rs 15.59 crore in 2023-24; Rs 437.87 crore in 2022-23; Rs 3,716.29 crore in 2021-22; and

Rs 3,976.17 crore in 2020-21.

The closing balance touched an all-time high of Rs 8,452.06 crore at the end of 2024-25, marking an increase of 17.83 per cent as compared to the closing balance of Rs 7,173.03 crore at the end of 2023-24.

The contributions to the Fund peaked in 2020-21, the year saw the outbreak of the second Covid wave, when it received Rs 7,183.77 crore as domestic donations and Rs 494.93 crore as foreign donations. In 2021-22, it got Rs 1,896.76 crore as domestic donations and Rs 40.12 crore as foreign donations; in 2022-23, it got Rs 909.64 crore as domestic donations and Rs 2.57 crore as foreign donations; and in 2023-24, it got Rs 681.81 crore as domestic dona-

tions and Rs 1.13 crore as foreign donations.

At the end of 2019-20, the closing balance was Rs 3,076.62 crore. This increased to Rs 7,014 crore at the end of 2020-21, fell to Rs 5,415.65 crore in 2021-22, and then climbed to Rs 6,283.68 in 2022-23, Rs 7,173.03 crore in 2023-24, and Rs 8,452.06 crore in 2024-25.

The PM CARES Fund was registered as a public charitable trust under the Registration Act, 1908, on March 27, 2020 -- days after the country went into a lockdown in the wake of Covid-19. The Prime Minister is the ex-officio chairman of the Fund, while the Defence Minister, Home Minister and Finance Minister are ex-officio trustees.

SC collegium approves six HC judges

New Delhi: The Supreme Court collegium on Tuesday approved the appointment of four advocates as judges of the Orissa High Court and of an advocate and a judicial officer as judges of the Gauhati HC. "The SC collegium...has approved the proposal for appointment of the fol-

lowing advocates as judges of the HC of Orissa: Sasmita Tripathy, Aditya Narayan Das, Rajjeet Roy and Gautam Misra," said a statement. It also approved appointment of advocate Nchumbemo Mozhui and judicial officer Helen Dawngliani as judges of the Gauhati HC. PTI

Chennai: Maternity leave for Tamil Nadu state government employees will be increased from the current 12 weeks to 365 days in the case of a third child, Minister for Human Resource Management D Sarathkumar told Assembly on Tuesday.

Currently, married women government employees with fewer than two children are granted 365 days of maternity leave, while those with two or more surviving children get up to 12 weeks of maternity leave. —PTI
