10.6 Steps Involved Register on https://BAANKNET.com using mobile number and email ID. Upload requisite KYC Documents. Pay EMD amount by Payment Gateways and also by Generate challan and transfer EMD amount to bidder’s EMD Wallet. Submission of bid shall be through Online mode on the auction date and time. In case of successful Bid, the balance bid amount to be paid as per the terms as mentioned hereunder. As per provision of Section 194-IA of Income Tax Act, 1961, TDS @ 1 % will be applicable on the sale proceeds or stamp duty value of such property, whichever is higher, where either sale proceeds or stamp duty value is Rs. 50,00,000/- (Rupees fifty lakhs) and above.
