In case of bidding, the bid increment shall not be less than Rs.90,000.00 (Rupees Ninety Thousand only), in excess of highest bid amount or the immediate preceding bid, as the case may be with multiple increment of Rs.90,000.00 (Rupees Ninety Thousand only) as mentioned above for each property.
