THE ground-plus-eight-floor facility will be among five regional cancer care centres planned at government medical college hospitals in Thanjavur, Coimbatore, Madurai, Tirunelveli and Villupuram. HPV DNA screening will be carried out for 1.22 lakh women in Dharmapuri, Villupuram, Tiruvannamalai, Tirunelveli and Thanjavur.

Another ₹2.77 crore will be spent on training doctors and providing nutritious food to patients. The state has also earmarked ₹106.17 crore for diagnostic tests, including radiation-related tests, Linear Accelerator facilities, and new equipment and services at government medical college hospitals.

Seven new government nursing colleges will be opened with 660 BSc Nursing seats, while 1,925 seats will be added to existing nursing colleges and schools. Another 2,778 seats will be created across 12 allied health

Services for gender-affirming surgery and treatment for transgender persons will also be expanded to Government Stanley Medical College Hospital and medical college hospitals in Tirunelveli, Thoothukudi, Chengalpattu, Tiruvapur, Dharmapuri and Kanniyakumari.

VILLUPURAM: A cybercrime awareness programme was held for students and teachers of arts and science colleges and government schools in Villupuram district on Wednesday, with around 6,000 students and teachers taking part. The participants were informed about various forms of cybercrime and online fraud and the measures to prevent them. Awareness was created about investment scams, part-time job scams and digital arrest scams. The participants were also cautioned against social media crimes. ENS

UDDALORE: Professors, employees and pensioners began a sit-in protest on Wednesday morning, demanding the release of pension and other retirement benefits to more than 300 teachers and employees who retired over the past two years. The protest began at the university's administrative office premises. It is organised by the Joint Action Committee of the Teachers, Employees and Pensioners Association of Annamalai University.
