M/s Geepot Enterprises availed All trade facility from Indian Bank (erstwhile Allahabad Bank), Jahangirabad Branch, Bhopal the repayment of which is secured by Mortgage of schedule mentioned property/ies hereinafter referred to as "the Property/ies". M/s Geepot Enterprises failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 04.01.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon M/s Geepot Enterprises, Sri Priyesh Bhargava s/o Sri Sunil Kumar Bhargava, Smt Priyanka Bhargava W/o Shri Vijay Shukla, Shri Vijay Shukla s/o Shri Brajbihari Shukla liable to the Bank to pay the amount due to the tune of Rs. 3,53,30,210/- (Three Corers Fifty Three Lakhs Thirty Thousand Two Hundred Ten only) together with interest from 05/01/2025 plus interest thereon & other charges due from 06.01.2025 to the Indian Bank. All failed to make payment despite Demand Notice dated 04.01.2025

As M/s Geepot Enterprises, Sri Priyesh Bhargava s/o Sri Sunil Kumar Bhargava, Smt Priyanka Bhargava W/o Shri Vijay Shukla, Shri Vijay Shukla s/o Shri Brajbihari Shukla failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 09.07.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

The Sale Proposed To Be Held Is By Way Of Public Tender /Auction Adopting The E-Auction Mode.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice

The amount due as on 01.08.2026 is Rs. 4,55,83,584/- (Rupees Four Corers Fifty Five Lakhs Eighty Three Thousand Five Hundred Eighty Four only) together interest thereon & other charges due from 02.08.2026

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 07.09.2026 which would be by e-auction mode.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/ postpone/cancel the sale without assigning any reason therefor.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale in the form of Banker's Cheque/ Demand Draft (Account Transfer and/ or any other acceptable mode of money transfer.
