However, the case is liable to be dismissed based on the Honourable Supreme Court Judgement dated 09/10/2020 in Civil Appeal No. 9519 of 2019 case of Dahiben Vs Arvindbhai Kalyanji Bhanusali (Gajra) AIR 2020 SC 3310, AIRONLINE 2020 SC 634. Further, the Bank has filed the application for rejection of plaint based on aforesaid case before the Civil Court Rajkot
